**MEMORANDUM OF ASSOCIATION**

**OF**

**TOTAL TRANSPORT SYSTEMS LIMITED**

- I. The name of the Company is TOTAL TRANSPORT SYSTEMS LIMITED\*
- II. The Registered Office of the Company will be situated in the State of MAHARASHTRA.
- III. The objects for which the Company Is established are:
  - A. THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION:
    1. To carry on business of Transportation of goods, merchandise live stock, passengers, and freight of all kinds and description between different places in India and In foreign countries from time to time by Sea, Land or Air or In combination of any or all of them and to carry on all or any of the following business I .e. general carriers, clearing and forwarding agents, handling of cargo, Packers and Movers, Warehousemen, Store-Keepers bonded carmen and common carmen, or any other business manufacture or trade which can conveniently be carried connection with the above.
  - B. THE OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS
    2. To acquire, purchase, hire, Motor Lorries, Motor bus, Launches and ships, aircrafts or any other carrier of whatsoever propelled by electricity, gas, gasoline, compressed air, steam, manual power, mechanised power, atomic energy or any other energy and to organise, maintain and operate Airways, Water, Ways, Railways, Roadways, and Road Conveyances or other means of transport of all kinds for the purpose of carrying clearing conveying, transporting goods, animals, passengers, merchandise or other things.
    3. To carry on the business of Garage Keepers, Hirers, Repairers, Cleaners, Stores and Warehousemen of Motor Cars, Motor Cycles, Scooters, Carriage Vans, and other conveyances of all kinds and description and suppliers of and dealers in Diesel, Petrol and other energy and to buy, sell, distribute, export, import, repair, assemble and deal in

garage and service station equipments, lubricants and all component parts, spare parts, accessories, apparatuses, articles and things of all description for use in connection with the maintenance and working of motors and vehicles of all types.

4. To acquire permit, for paying lorries, buses, cars, taxis, boats, steamers, aeroplanes, helicopters or any other form of vehicles with a view to operate and run in India and elsewhere and to own and operate motor lorries, trucks, trailers, tankers, cranes, forklifts, vessels, launches, steam ships, aeroplanes, helicopters and any other type of vehicles.
5. To lend and advance money or give credit with or without security to such persons or companies and on such terms as may seem expedient and to guarantee or become liable for the amount of money or for the performance of any obligations, and generally to transact all kinds of guarantee business and also to transact all kinds of trust and agency business.
6. Subject to Section 58A of the Companies Act, 1956, and the Directives issued by the Reserve Bank of India to receive money on deposit or loan & to borrow or raise money in such manner as the Company shall think fit, and in particular by the issue of debentures, or debenture stock & to secure the repayment of any money borrowed, raised or going by mortgage, charge, lien upon all or any of the property (both immovable & movable) of the Company (both present & future), including its uncalled capital and also by similar mortgage, charge, lien to secure & guarantee the performance by the company or any other person or company of any obligation undertaken by the company of any other person or company or hypothecate or pledge of all movable property of whatever description may be.
7. To purchase, take on lease or in exchange, lien, or otherwise acquire any real & personal property of any rights or privileges which the Company may think necessary or convenient for the purpose of its business.
8. To acquire & undertake the whole or any part of the business property of any person or Company, carrying on (or proposing to carry on) any business which the Company is authorised to carry on for such consideration as the Company may think fit.
9. To sell, or dispose of the business, property or undertaking of the Company or any part thereof for such consideration as the Company may think fit and in particular for share, debenture, or securities of any other Company.
10. To apply for purchase or otherwise acquire ( and protect or renew in any part of the world) and patents (patent rights) inventions (trade marks, designs) licences, concession, copyright and the like conferring any exclusive or limited right to their use, or any secret or other information as to any invention, which may be capable for the Company for any of the purpose to use it.
11. To open branch offices, in Maharashtra or elsewhere in India or abroad.
12. To deal or invest the Company's surplus money from time to time in such a manner or to be determined by the board of Directors and to hold, sell otherwise deal with such Investments.
13. To amalgamate or to enter Into partnership or into any arrangement for sharing profits, union of interests, cooperation, joint-venture, licence, or reciprocal concession or for limiting competition with any person or persons or Company or Companies carrying on or engaged in, or about to carry on or engage in, or being authorised to carry on or engage in any business or transaction which the Company Is authorised to carry on or engage In or which can be carried on in conjunction therewith.
14. To foster, assist, promote, encourage in India & in foreign countries literacy, scientific & commercial research.
15. To open bank accounts of all nature including overdraft account and to operate the same and to draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, warrants, debentures and the other negotiable or

transferable instruments and to deal with all documents mercantile or otherwise, in the ordinary course of business.

16. To remunerate any person or company for services rendered or to be rendered in placing or assisting to place or guaranteeing the placing of any of the shares in the Company's capital or any debentures, or other securities of the company in or about the formation or promotion of the Company or the conduct of its businesses.
17. To insure with any person or company against losses, damages, risks and liabilities of any kind which may affect the Company either wholly or partially, and if thought fit, to effect any such insurance by joining or becoming members of any mutual insurance, protection or indemnity association, federation or society and to accept any such, insurances, or any part thereof, for the account of the Company.
18. To employ experts to investigate and examine into the conditions, prospects, value, charter and circumstances of any business, undertakings and generally of any assets, property or rights.
19. To apply for membership or become a member of any company, association society or body corporate having any objects similar to or identical with those of the Company, or likely, directly or Indirectly, to promote the Interest of the Company.
20. To grant pension, allowances, gratuities, benefits, emoluments and bonuses, provident fund and superannuation funds to employees, former employees and Directors of the Company and other dependents upon them, and to construct or contribute to the construction of houses, dwelling or quarters for the employees of Company and of other concerns which are or may by contractual relationship with rendering any service to the Company and to join with any other person, firm or company In doing any of these things.
21. To support, donate, contribute and subscribe to any charitable, religious educational or other public institutions trusts, clubs, societies or individual or body of individuals.
22. To undertake and execute any trusts, the undertaking whereof may seem desirable and/or gratuitous or otherwise, and in particular to act as depositories of any shares or securities of, and as agents or brokers for the investment, loan, payment. transmission or collection of money,, and purchase, sale. hire, improvement or development and management of property, movable or immovable for any company, firm or person form sub-contracts.
23. To act as principals,, agents, trustees, corporations, contractors or otherwise and by or through trustees, agents, corporations, contractors or otherwise and 'either atone or in conjunction with any other or others, whether in India or anywhere else in the world.
24. To adopt means of making know the business of the Company as may seem expedient and in particular by advertising in the press, by circular, by exhibition of works of art or Interest, by publication of books and periodicals, and by' granting prizes, rewards and donations.
25. In connection with the business of the Company, to purchase, take on lease or in exchange or otherwise acquire, erect, sell and otherwise deal in any lands or buildings and factories having plant and machinery and other equipments, and any other estate or interest in, and any other rights connected with any such lands and buildings in India or elsewhere.
26. In connection with the business of the Company, to develop and turn to account any land acquired by the Company or in which the Company is interested, and in particular by laying out and preparing the same for building purposes, constructing buildings, godowns, public works, by simple process or by using pre-fabricated materials, altering, pulling down, decorating, and by planting, draining, paving, letting, buildings on lease or building agreement, and by advancing to and entering into contract and arrangements of all kinds with builders, tenants and others, in India and/or abroad.

C. OTHER OBJECTS :

27. To carry on business of manufacturers and dealers in all types of containers, boxes made of out of plastic polythene allied materials and to manufacture other packing materials such as bags, cans, cases, pans, caks, chests, create, jars made or out of (a) plastic, (b) paper and paper material, (c) cane, (d) rubber, (e) wood and board, (f) metals of all kinds, (g) fabrics or other commodities whatsoever used or capable of being used in manufacture of such packing materials.
28. To carry on all or any of the business of makers of and dealers in scientific and industrial instruments of all kinds for indicating, recording, controlling, measuring and timing and machine tools, precision tools, surgical instruments and appliances and artificial limbs, dental and optical equipment and goods, anatomical orthopedic and surgical appliances of all kinds providers of all requisites for hospitals, patients and invalids.
29. To carry on business of Lodging and Boarding, restaurants eating houses, clubs, bars, Pubs dressing rooms, laundries, beauty parlours, hair dressing saloons, library wine, beer and spirit Merchants, dealers in all kinds of foods and drinks and other facilities to public including tourists, and guests and to carry on the business or businesses whether together or separately as proprietors and operators or amusement parks, and as organisers and managers of all kinds of entertainments sports, recreations of amusements, whether indoor or outdoor, including casions, funfairs, exhibitions, sideshows and games. competitions, tournaments, concerts, cinematograph and television performances, stage and variety shows, aquatic and equestrian events, pyrotechnic, aenial and spectacular displays, dancing, skating, bowling alleys and other forms and. types of like entertainment.
30. To act as manufacturers, assemblers, fabricators and dealers of electronic, thermal, ultrasonic, equipments and Instruments of all kinds and descriptions including radar equipment computers, electronic accounting and business machines, electronic communication equipments, electronic control Instrument and basic distaphones, components, such as valves, transistors, recorders, condensers, coils, magnetic materials and microwave components, radiographs, photographs, dictaphones, television sets) record players, tape amplifiers, medical equipments and other electronic and electrical instruments and components, used in any industry or for defence, computer, medical research, recreation, educational or domestic purposes.
31. To carry on the business of agriculturists, horticulturists, sericulturist, aquaculturist, planters, cultivators, farmers, dealers of all produce of soil or water and specially to plant, grow, cultivate, import, export, buy. sell, process, manufacture, blend refrigerate, store, package and in any other way deal in tea, coffee, tobacco, cinchona, cardamum, rubber, cocoa, jojoba, cereals, food grains, spices, mushrooms fungai, food stuff, fish oil and other seeds, all varieties of fruits, and vegetables, flowers, coconuts, fish, shrimp ground nuts. cashew nuts, almonds, and other varieties of edible and inedible nuts and all kinds of trees whether ornamental or commercial and whether hard or soft wood, plants and other fibrous material and such other articles that are the produce of land, soil or water and all products and by-products thereof and prepare, manufacture, and render marketable any such produce and to sell, dispose off, purchase and deal in such produce either when it is prepared, manufactured or roasted and either by wholesale, retail or other such commercial method.
32. To carry on the business as manufacturers, merchants, traders, buyers, sellers agents, importers, exporters, dealers distributors or in any other capacity and to import, buy, sell or otherwise trade and deal in merchandise of any kind whatsoever and without prejudice to the generality of the forgoing, general produce, foodgrains, cash crops, cotton, tea, jute, textiles, coffee, fruits, spices, vegetables, flowers, meat, seeds, substances, goods, raw materials required by industries, semi finished products of industries and finished products of industries including machinery and equipment including textile machinery its spare parts and pharmaceutical products, raw material require) for pharmaceutical accessories, chemicals, dyes, intermediates fertilisers, ores, oils electrical goods, electronic devices and components, textile yarns, cloths, garments

and furnitures agricultural commodities, dairy, farm and garden produce and in particular milk raise in and its allied products including cheese butter, tinned milk, condensed including cheese butter, tinned, milk, condensed milk and preserved milk, dried milk concentrated milk the products and substances derived from the manipulated of or treatment of milk, cream, ice-creams, ghee, poultry, eggs. fruits, vegetables, pickles and cider as wholesalers or retailers on the basis of ready delivery.

33. To carry on the business of maintaining operating, purchasing selling, taking or giving on lease or otherwise acquiring dairies poultry farms, horticultural farms, sericultural farms, tissue culture farm, gardens, orchards and doing cow keeping, buffalo keeping, goat and sheep keeping, horse breeding and keeping
34. To carry on the business as builders and general construction contractors and own. sell, acquire, process, develop, construct demolish, enlarge, rebuild, renovate, decorate, repair, maintain, let out, hire, lease, rent, pledge, mortgage, invest intermediaries, or otherwise deal in construction of all description like land, buildings, flats, shops, commercial, educational and non-commercial complexes, houses and other immovable properties of any tenure and any interest therein, hotels, cinema houses, auditoriums, galary, club houses, roads, body buildings, airports, towers, platforms, highways, tunnels, pipelines, hospitals, nursing homes, clinic, godowns, warehouses, factories, colleges, schools, townships, freehold and leasehold ground and land, developing, property in general.
35. To manufacture, assemble, buy, sell, distribute, import, export, alter, remodel, hire, exchange, repair, service and deal in, buses, bus bodies motor vehicles, passengers cars, jeeps, chassies, motor vans, modular vans, integral coaches, tippers, dumpers, fire fighting vans, ambulances, school buses, executive vans, oil tankers, chemical carriers, earth movers, refrigerated vans, luxury coaches air-conditioned vans. Milk vans. cash vans, postal vans, security vans, mobile dispensaries, mobile restaurant vans, caravans, and all the present and future types of autovehicles,
36. To carry on business as manufacturers, producers, importers, exporters, processors, makers, buyers, sellers, suppliers, stockiest, agents, merchants, manipulators, distributors and wholesale and retail dealers in all types of Inks and its ingredients including Ball-Pen Inks, Roller Pen Inks, Hiliter Inks, Wipe out Inks, Magnetic Inks, Stamp Pad Inks, Writing Inks, Printing Inks, Inked Ribbons, Ink Tapes, Ink Chemicals, Computer Inks, Adhesive Inks, Laminates, Favicol, and Solid Inks.
37. To carry on the business of brewers, distillers, rectifiers, mathylators, malsters, and to manufacture, import, export and deal in beers, country and foreign wines, spirits and liquors, commercial, industrial and absolute alcohol, rectified, methylated and sweet spirits, mineral and aerated waters.
38. To carry on the business as travel and tourist contractors and agents in general and. to organise tours and excursion, whether religious, educational, sight seeing business or otherwise whether in India or abroad, and to carry on the business of handling inward foreign tourist activity in India including independent and conducted tours, safaris, expeditions, conferences, meetings, and other group movements and also to handle similar foreign tourist activity in other parts of the world through its own offices and agents and correspondents, and to provide services of booking tickets, circular tickets, sleeping cars or berths for all modes of travel, hotel places boarding, and/or lodging accommodation.
39. To carry on the business of perfumers, perfuming agents and to manufacture and deal in essences and cosmetics.
40. To carry on the business as manufacturers, processors, repairers, wholesalers, retailers, stockists, importers, exporters and dealers In all types of footwear and shoes, such as boots, chappals, slippers and footwear accessories, such as heel, soles, buckles, belts, protectors, bands, straps, boot-laces, boot-polishes, packing, including handgloves of leather and dresses.

41. To carry on the business of advertising and publicity, Marketing and Propaganda Agents and Advisers to Manufacturers, Traders and Dealers and promote the sale of their products and services through various, media such as newspapers, periodicals, magazines, journals, cinemas, point of sale publicity, direct mail publicity, display units.
42. To carry on the business of teasing, giving on hire-purchase, lending, selling, re-selling or otherwise disposing of all forms of immovable and movable properties and assets including buildings, godowns, warehouses and real estate of any kind, all types of industrial, office and other plant, equipment and machinery, including heavy or medium industrial machinery, computers, electronic and electrical apparatuses, air-conditions, medical equipments, domestic equipments and appliances, all types of vehicles.
43. To carry on the business of manufacturers, exporters, importers and dealers in all types of electronic devices, components, equipments and appliances, including Television, Audio, Video, Radio, Tape Recorders, broadcasting and reception equipments used in and for audio and visual communications, digital and other electronic clocks, time relays, automatic calculators, Capacitors, resistance, condensers, semi-conductors and allied items intended for and used in electronic devices.
44. To carry on the business of manufacturers, exporters, importers and dealers in Computers, hardware, software, and other related equipments or machineries for the purpose of establishing of providing, importing, exporting or otherwise dealing in any kind of data processing, data entry, data preparation and to act as consultants and provide technical know-how and any or kinds of services for advice or training in technology, system analysis and experiment.
45. To finance industrial enterprises, to promote, companies engaged in industrial and trading business, and to tend money either with or without security and to such persons or bodies corporate and upon such terms and conditions as the Company may think fit and for that purpose to invest the capital and other moneys of the Company in the purchase or upon the security of shares stocks, units, debentures, debenture-stock, bonds, mortgages, obligations and securities of any kind issued or guaranteed by any company, corporation or undertaking of whatever nature, whether incorporated or otherwise and whatsoever constituted or carrying on business and to acquire, hold, sell, buy or otherwise deal in any shares, stocks, debentures, debenture-stock-stock, bonds, mortgages, obligations and other securities or guaranteed by any Government or other authority or body of whatever nature in India or abroad, by participation, tender, purchase, exchange, gift or otherwise and to subscribe for the same, either, conditionally or otherwise and to underwrite or sub-underwrite or guarantee the subscription thereof and to purchase and sell units.
46. To carry on the business of warehousing, warehousemen, custodians, and to establish warehouses, storage rooms, godowns, cold storage, bins and to provide facilities for storage of commodities, merchandise, articles and things of any description, and to make arrangements for clearing, forwarding, transporting, removal and distribution of goods stored and also to act as packers, hauliers, transport, cartage and haulage contractors and clearing, forwarding, transport and commission agents and to provide such other facilities of warehousing, storing and safe custody of goods received from customers for a particular period on such terms and conditions as may deem expedient.
47. To carry on the business as buyers, sellers, importers, exporters and manufacturers of all kinds of articles of wearing apparel, garments and dress and household and domestic and other linen fabrics and materials made out of all Textiles and ready-made or made-to-measure garments, drapers and hosiers, clothiers, dress makers, costumiers, dress agents, tailors and outfitters and all articles of wearing attire for personal or household use, decoration or ornament.
48. To undertake, carry out, promote and sponsor and assist any activity for the promotion and growth of national economy and for discharging social and moral responsibilities of the Company to the public or any section of the public as also any activity likely to promote national welfare or to undertake any activity of conversion of natural resources or social, economic or moral uplift of the public or any section of the public and without

prejudice to the generality of the foregoing, and in such manner by such means from time to time to undertake, carry out promote and sponsor any activity for publication of any books, literature, newspapers or for organising lectures or seminars, likely to advance these objects or for giving merit awards, scholarships, loans or any other assistance to deserving students or other scholars or persons to enable them to prosecute their studies or academic pursuits or researches or to take up establishment of any Medical Research Centre, to collect information and advices on modern techniques for treatment of diseases for the benefit of the rural areas either by itself or through any of the agencies and for establishing conducting or assisting any institution, fund, trust, having any one of the aforesaid objects as one of its objects by giving donations or otherwise in any other manner in order to implement any of the abovementioned objects or purposes, transfer without consideration or at fair or concessional value and subject to the provisions of the Companies Act, divest the ownership of any property of the Company to or in favour of, any Public or Local Body or Authority or Central or State Government or any Public Institutions.

49. To undertake, carry out, promote and sponsor rural development including any programme for promoting the social and economic welfare of or the uplift of the public in any rural area and to incur any expenditure on any programme of rural development and to assist execution and promotion thereof either directly or through an independent agency or in any other manner, Without prejudice to the generality of the foregoing "programme of rural development" shall also include any programme for promoting the social and economic welfare of or the uplift of the public in any rural area likely to promote and assist rural development, and that the words "rural area" shall include such areas as may be regarded as rural areas under Section 35CC of the Income-tax Act, 1961, or any other Law relating to rural development for the time being in the force as rural areas and in order to implement any of the abovementioned objects or purposes, transfer without consideration, or at such fair or concessional value and subject to the provisions of the Companies Act, divest the ownership of any property of the Company to or in favour of any public or Local Body or Authority or Central or State Government or any Public Institutions.
50. To carry on the business of Investment & Financing in all its aspects, to act as Managers to issues of shares, stocks, debentures, bonds, units, participation certificates, deposit certificates, notes, bills, warrants or any other instrument whether or not transferable or negotiable, to act as agents, of and/or dealers in the securities in the course of merchant banking business, to act as discount house for any of the securities, to act as financial consultants, joint Managers, lead Managers, Co-Managers, advisers and counsellors in investment and capital markets, to underwrite, subunderwrite or to provide stand by or procurement arrangement, to issue guarantees or to give any other commitment for subscribing or agreeing to subscribe or procure or agree to procure subscription for the securities, to act as issue house, registrars to issue, custodians, partfolio Manager, transfer, agents, for all kinds of securities, and investment instruments, to manage and administer computer centres and clearing houses for the securities, to act as brokers, dealers and agents in connection with the shares and securities of all types and for this purpose become member of any of all stock exchanges, over the counter trading exchanges, national stock exchanges whether in domestic market or in international market, & to create mutual funds. To carry on and undertake the business of finance, investment and trading, hire purchase, leasing and to lease finance.
51. To establish, provide, maintain and conduct or otherwise subscribe, analytical and research laboratories, experimental stations, workshops and libraries for scientific, industrial and technical researches experiments and tests of all kinds and to undertake and carry out research and investigations, to process, improve and invest new and better techniques and methods of manufacturing any products and improving or securing any process or processes, patent or patents or copy rights which the Company may require or propose to acquire or deal with and to promote studies research, surveys and investigation, both scientific and technical, by providing subsidising, endowing of assisting laboratories, colleges, universities, workshops, libraries, lectures, meetings, exhibitions and conferences and by providing for the remuneration to scientists,

scientific or technical personnel or teachers, research workers and inventors or otherwise generally to encourage, promote and reward studies research, investigations, experiments, tests, and inventions of any kind that may be considered likely to assist any of the aforesaid business of the Company,

52. To carry 'on the business of recording,, reproducing, duplicating and processing on video cassettes, video-grams, video discs and such other media all types of films and features including Documentaries, India and Foreign dances, India or Foreign features films of places of Tourist interest and Historical importance, India cultural features such as festivals and the like and similar objects for viewing on Television set and/or for viewing/exhibition In cable, T.V. Video parlours and any other such place and distribute video films, serials, documentaries of all types.
53. To carry on the business of importing exporting, buying, selling and dealing in all types of FAX Machines, including EPABX Systems, Telephone, instruments, wireless apparatus, radio receivers and transmitters, broadcast, relay and reception equipments, phonographs equipments, used in and/or for audio and Telecommunication and those using electromagnetic waves intended for radio telegraphic or radiotelephonic communication
54. To carry on the business of providing, arranging, maintaining and operating all kinds of vital network services required by any person whosoever and to conduct vital Services bureau, exhibition cum-sale, market research and survey so as to promote the sale of the products of various manufacturers including courier and cargo services so as to facilitate the business community in transportation of quick supply and delivery including communication net work and Telecommunication Systems, FAX and EPBX Systems, inter communication systems, teleprinter system and to render technical and management consultancy and services including maintenance in connection with the use and other services.
55. To carry on business as exporters, manufacturers, researchers, importers, buyers, sellers and dealers of and in alkalies, cordials, paints, soap and toilet goods, petrochemicals, fertilisers, salts, graphite, cosmetics, starches, industrial solvents, polishers and all intermediate products, by-products and derivatives tannins, essences pharmaceuticals, photographic, sizing medical, industrial and other preparations.
56. To carry on the business as growers, farmers, harvesters proprietors, agents, processors, sellers, buyers, extractors, canners, cultivators, distillators, importers, exporters and dealers of agricultural products, including cotton, jute, flax, rubber, hemp, grass, timber, bamboo, straw, tea, coffee, cocoa, cinchona, food products including wheat, barley, rice. papervite, spicate, cardears, paimrose. maize, sugar cane, beet. millets, mushrooms, vegetables and fruits, other horticultural products and floricultural products and any other articles produced from land and essences, pickles, ciders, jams, chutneys, marmalades, vinegars, sausages, ketchups, squashes, juices, syrups, drinks, including beverages produced from these or other products, chocolates, preserved, dehydrated, canned or converted fruits and vegetables processed foods, sugar products and to carry on the business of cold storages, refrigerating, cooling of all the aforesaid products or otherwise on company's own account or as contractors, lessors and the lessees.
57.
