About the Joint Venture:

The agreement was signed between parties on 23rd August. Seedcor who currently own "Seedcor Europe" will merge his European holding. Seedcor Europe will maintain 70% shares and Total Transport will be assigned with 30% of the shares of the JV Company. Seedcor will appoint the Managing Director and General Manager whereas Total Transport will provide at least two senior staff to sell the services of the JV in India.
